- Florida Statutes, Chapter 720

Per Florida Statute: 720.306, Quorum verification for HOA's requires 30% +1

- Covenants & Restrictions, Rules & Regulations

Homeowners, <u>all outside modifications must be submitted to the Architectural Committee</u> for review and Board approval. IE: Paint, Roofs, Decks, Fencing, Sheds, Etc.

- Harassment of Board Members There will be "ZERO" tolerance from Homeowners.
- Yard Waste

The FEMA cleanup is complete, all yard waste must be placed in plastic bags and placed by the road side for Wednesday pick up.

Please remember, the town is still only picking up three (3) bags per 'household' until further notice.

- Limbs and/or tree branches should be placed as close to the road, a path and/or walking trail as possible, that way Gales and/or Joe & Terry can take them over to where the 'City' picks up debris.
